Sub: Update on transaction in relation to Acquisition of Equity Stake in Thriveni Pellets Private

This disclosure is being made pursuant to Regulation 30(7) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and further to our earlier disclosure dated 12<sup>th</sup> August, 2025, regarding the outcome of the meeting of the Board of Directors of Lloyds Metals and Energy Limited ("the Company"), wherein the Board, inter alia, approved the acquisition of a 49.99% equity stake in Thriveni Pellets Private Limited ("TPPL") and the issuance of equity shares on a preferential basis to Adler Industrial Services Private Limited ("AISPL"). As stated in the aforementioned disclosure, the said transaction was subject to the approval of the Competition Commission of India ("CCI"). We are pleased to inform you that the CCI, vide its letter dated 7<sup>th</sup> October, 2025, has approved the acquisition of 49.99% equity share capital of TPPL.
